

2019 Mini-Split Ductless Heat Pump Rebate Instructions

City of Olivia

By participating in the We Save program, you can save energy and earn a rebate when you purchase a qualifying mini-split ductless heat pump.

What rebate can I earn?

Mini-Split Ductless Heat Pump: \$200

What units qualify for rebate?

To qualify for this rebate, the mini-split ductless heat pump must be certified by the Air-Conditioning, Heating, and Refrigeration Institute (AHRI) and meet the following minimum efficiency ratings: 15.0 SEER, 11.0 EER, and 9.0 HSPF.

What does it mean to be AHRI certified?

To be AHRI certified, manufacturers' products undergo testing by independent laboratories under contract to AHRI. Equipment and components are evaluated using the appropriate industry standard to certify that manufacturers' published performance ratings are accurate.

How Do I Qualify?

- Residential customers receiving electric service from the City of Olivia are eligible for a rebate when they purchase a qualifying mini-split ductless heat pump.
- **System must be listed on AHRI directory.**
- Ducted or mixed-ducted units are not eligible for this rebate.
- Information on rebate application must match invoice.
- Customer must apply for rebate within one year of the purchase date shown on the invoice.
- Rebate application must include complete contractor and equipment information and include a copy of dated invoice showing manufacturer, model number, serial number, and a copy of AHRI Certificate. Incomplete rebate applications will not be processed.
- Limit one rebate per customer account per year.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2019.
