# **RESOLUTION NO. 2023-103 RESOLUTION ADOPTING ASSESSMENT**

WHEREAS, pursuant to proper notice duly given as required by law, the council has met and heard and passed upon all objections to the proposed assessment for the **DePue Avenue Improvement Project**, on the following streets:

- Depue Avenue from 1st Street to 13th Street (TH 71)
- 1st Street from Depue Avenue to Fairview Avenue
- 2nd Street from Depue Avenue to Lincoln Avenue (US TH 212)
- 7th Street from Depue Avenue to Lincoln Avenue (US TH 212)
- Alley between 7th Street and 8th Street from 13th Street (US TH 212) to DePue Avenue
- 10th Street from Fairview Avenue to Lincoln Avenue (US TH 212)

Improvements include but are not limited to construction of sanitary sewer, sanitary sewer services, water main, water services, storm sewer, concrete curb and gutter, aggregate base, bituminous street surfacing, turf restoration, and miscellaneous items required to complete the improvements.

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF OLIVIA, MINNESOTA:

- 1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the lands named therein, and each tract of land therein included is hereby found to be benefited by the improvement in the amount of the assessment levied against it.
- 2. Such assessment shall be payable in equal annual installments, including principal and interest, extending over a period of 20 years, the first of the installments to be payable on or before the first Monday in January 2024, and will bear interest at a rate of 5.00 percent per annum from the date of the adoption of this assessment resolution. To the first installment shall be added interest on the entire assessment from the date of this resolution until December 31, 2024. To each subsequent installment when due shall be added interest for one year on all unpaid installments.
- 3. The owner of any property so assessed may, at any time prior to certification of the assessment to the Renville County Auditor-Treasurer, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the City of Olivia except that no interest shall be charged if the entire assessment is paid by November 29, 2023, and he may, at any time thereafter, pay to the City, the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the succeeding year.

4. The City Administrator shall forthwith transmit a certified duplicate of this assessment to the Renville County Auditor-Treasurer to be extended on the property tax lists of the county. Such assessment shall be collected and paid over in the same manner as other municipal taxes.

### RESOLUTION APPROVING FIRST AMENDMENT TO THE CONTRACT WITH MARCUS CONSTRUCTION FOR IMPROVEMENTS TO CITY HALL AND THE PUBLIC SAFETY BUILDING OF THE CITY OF OLIVIA

WHEREAS, the City of Olivia Minnesota (the "City") is a statutory city and has the right, pursuant to Minnesota Statutes, Sections 412.201 and 412.221, as amended, to enter into and execute contracts for improvements within the City; and

WHEREAS, the City had previously identified the need for improvements to City Hall and the Public Safety Facility (the "Project"), had hired Marcus Construction on July 21, 2023, as the Construction Manager to oversee the Project and had entered into an agreement with Marcus Construction using AIA documents, including A133-2019 and A201-2017 ("Project Agreements"); and

WHEREAS, the Minnesota Legislature adopted Minnesota Statute Section 471.463, effective on August 1, 2023, to allow municipalities to use a construction manager at risk method of project delivery subject to the parameters set forth in that statute;

WHEREAS, the City and Marcus Construction desire to amend certain provisions of the A133 and A201, including Section 1.1.8 and Section 4.2 of A133 and Section 2.1.1 and Section 4.2 of A201 regarding authority delegated to the City's "Owner representative" for the Project; and

WHEREAS, as part of the agreement, the City Council may designate an Owner's Authorized Representative to whom Council can delegate authority to approve changes up to a certain amount with respect to the Project; and

WHEREAS, Minnesota Statutes Section 412.217, subdivision 8 provides statutory authority for the City Council, at its discretion, to delegate its authority to the City Administrator as Owner representative for the Project to approve certain claims resulting in an increase to the approved contracts with that increase being brought to Council for informational purposes at the next regular meeting of Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Olivia Minnesota that:

Section 1. <u>The First Amendment to Project Agreement</u>. The Council approves the First Amendment to the A133 and A201 Agreement, attached to this resolution, with Marcus Construction making the modifications readily identifiable through the Additions and Deletions Report at the end of the Project Agreement. The Mayor and City Clerk are hereby authorized and directed to execute and deliver the First Amendment to Agreement. All of the provisions of First Amendment to Agreement, when executed and delivered as authorized herein, shall be deemed to be a part of this resolution as fully and to the same extent as if incorporated verbatim herein and shall be in full force and effect from the date of execution and delivery thereof. The First Amendment to Agreement shall be substantially in the form on file with the City which is hereby approved, with such omissions and insertions as do not materially change the substance thereof, or as the City Administrator, in their discretion, shall determine, and the execution thereof by the Mayor and the City Clerk shall be conclusive evidence of such determination.

Section 2. <u>The Owner Representative Authority</u>. The City Council hereby designates the City Administrator to serve as Owner's representative and authorizes the City Administrator to approve increases in the manner and up to the amounts set forth in the Project Agreements, with any approved increases coming in front of Council for informational purposes at the next regular meeting of Council after the approval.

#### Section 3. <u>Miscellaneous.</u>

3.01. The recitals set forth herein are incorporated into and made a part hereof.

3.02. The City Administrator, and staff are hereby authorized and directed to take any and all additional steps and actions necessary or convenient in order to accomplish the intent of this resolution.


