# **Housing Work Session**

Jasmine Frias provided an overview of the Southwest Minnesota Housing Partnership (SWMHP) and their recent outreach efforts associated with the county's housing plan. Frias shared with the board the program that is in the development phase at the county for two- and three-bedroom homes to possibly be built in the ten Renville County communities. Additionally, she reminded the board of the housing efforts at the federal level that will bring \$40 million dollars to small towns to complete housing developments. The formal announcement is anticipated to come in November of 2023 with application due sometime in January of 2024.

# **Tree Request**

Joe Wittman asked if the board would be willing to sell up to 17 trees from the EDA owned property by Thrifty White. Lang was instructed to work with Kennedy and Graven to draft a purchase agreement and take action at the next EDA meeting.
